

KINDER Final Conference

The KINDER final conference will take place online, being broadcasted on YouTube (https://youtube.com/live/Wp9KvelMFI0?feature=share) to the general public and to national professionals who participated in the project in each of the partner countries, consultants, public authorities, decision makers and other people relevant to the project.
