RETHINKING URBAN INCLUSION: SPACES, MOBILISATIONS, INTERVENTIONS

Faculty of Economics, University of Coimbra Coimbra, Portugal, 28 June – 30 June 2012

The Conference aims to understand and ultimately rethink social inclusion at the urban scale, as the product of broader dynamics and the interaction of different actors and languages. It will focus on emerging modes of contesting the centrality of the state and market pervasiveness, new varieties of counter-hegemonic positions and projects, and alternative visions of urban democracy and justice that inform bottom-up and participatory approaches to urban inclusion. By mixing academic with social movement and civil society "expertise," experiences of both the global North and the global South, and the languages of social science and policy with those of the humanities and art, the Conference aims to contribute to an "ecology of knowledges" that gives visibility to new forms of collective action and community experimentation reshaping contemporary cities in different contexts.

The event is organized along three main axes/typologies of activities:

- 1. **Plenary sessions** with keynote speakers from different parts of the world;
- 2. **"In conversation with..."** sessions, which are more informal dialogues with senior scholars and young researchers, discussing with the audience specific themes from very different and complementary disciplinary perspectives; and
- 3. **Concurrent panel sessions** organized around specific issues and themes:
 - A. Inclusion Between Global and Local; Migrants, Inclusion and Exclusion
 - B. Global Histories for the Urban Future; Evicting Workers for the New City; Ethnographies of Participation; Local Government and the Social
 - C. Urban Justices and the City; Environmental Justice; Greening the City; Solidarity Practices
 - D. Practices of Urban Protest; Right to the City
 - E. Public Spaces in Dense Cities; Dense Cities: Architecture Expertise against the Politics of Suburbanization; Dense Cities: Portuguese Urban Histories for Densification; Urban Participation Practices

Dinner and Alternative Tour of Coimbra

Thursday, June 28 - Conference Dinner

Thursday's welcoming dinner will be an excellent opportunity to get to know each other in the enchanting setting of the Vertical garden situated in the University of Coimbra's Botanical Garden, one of the oldest in Europe, featuring some monumental trees and a bamboo forest. The vertical garden is the beating heart of Transição Coimbra (Transition Network – Coimbra), an initiative of a group of engaged citizens interested in increasing local resilience through positive action. In the vertical garden this is done by showing inspiring examples of how food can be grown in urban settings with little space available and demonstrating how to do that. Especially for this occasion, the space is decorated with the fairy-like light objects of artist Jutta Weiske. The dinner will include a Mediterranean and an Indian line of hot and cold, vegetarian dishes with plenty of choice to please your senses and allow for special needs (lactose free, vegan, halal). Most ingredients are crispy fresh, organic and local, from producers that have a relation with the Botanical garden's farmer's market on Saturday morning. The menu:

- · Gazpacho and exotic soup with homemade bread and a series of bread spreads and olives
- · Lentils "thousand-and-one-nights" with different chutneys and sauces
- Zesty, mediterranean tofu and vegetable stew
- Rich buffet with a variety of side dishes, like couscous, rice, roast potatoes and different colourful, tasty salads
- Dessert buffet featuring seasonal fruits, puddings and pastry with some exotic touches.
- Drinks that will be served: organic wine, water, a variety of herb teas and refreshing long drinks and coffee.

Sunday, July 1 – An alternative perspective on Coimbra

Venue: Guided visit with "alternative insights" into the city of Coimbra, Portugal

The city of Coimbra is widely renowned for its close relationship with the University, which has broadly marked the urban space during the city's history. This relationship has been strengthened during the last century, especially modifying the uptown (Alta) area. Thus, visiting the University coincides with visiting the core of the city, through the spaces that host the spaces of knowledge (the Pátio das Escolas, previously the Arab Alcáçova, then the Royal palace and – from the XVI century – the University) and the residential areas for students, especially the famous large diversity of "Republicas," a type of student house with commonly shaped rules. Our tour will dedicate the morning to better understand such spaces, and the roles they played in controlling the training of the elites who dominated the Portuguese empire during the colonial period.

But Coimbra is not only the University: it is also the space around the Mondego River, with its park, the "Portugal of Kids" (with its strong colonial bias) and the museum area of Santa Clara-a-Velha, as well as a wide multiplicity of peripheral neighbours forged by the fights of social movements and cooperative groups after the Revolution of 1974. The second part of the tour will focus on visiting several different spaces where alternative ways of living gradually took shape: social housing estates, community allotment gardens, protected natural areas and active associations. Our guides will be architects as well as citizens who live in these places, because "cities are us"...

Keynote biographies

AbdouMaliq Simone teaches sociology at Goldsmiths College, University of London and has taught at various universities in Africa and the USA. As an urbanist he has carried out research on African cities and more recently on southeast Asian cities. He combines his pan-African experience working with NGOs, municipal government and community upgrading projects together with research on urban culture, policy, international relations and critical theory. Simone's research points to the inadequacy of modernist discourses in understanding the contemporary realities of non-western cities.

Raquel Rolnik is an architect and an urban planner, with over 30 years of experience in planning and urban land management. She has a large experience in the implementation and evaluation of housing and urban policies. Based in Sao Paulo, she is a professor at the Faculty of Architecture and Urbanism of the University of São Paolo and is the author of several books and articles on the urban issue. In her career, she has held various government positions including Director of the Department of Planning of the City of São Paulo (1989-1992) and National Secretary for Urban Programs of the Brazilian Ministry of Cities (2003-2007) as well as NGO activities. She was appointed at the 7th session of the Human Rights Council as the second United Nations Special Rapporteur on adequate housing as a component of the right to an adequate standard of living, and on the right to non-discrimination in this context. She has taken up her functions of Special Rapporteur since May 1, 2008.

Robert D. Bullard is Dean of the Barbara Jordan-Mickey Leland School of Public Affairs at Texas Southern University. Prior to coming to TSU he was founding Director of the Environmental Justice Resource Center at Clark Atlanta University. He has been described as the father of environmental justice. He received his PhD degree from Iowa State University. He is the author of seventeen books that address sustainable development, environmental racism, urban land use, industrial facility siting, community reinvestment, housing, transportation, climate justice, emergency response, smart growth, and regional equity. *Keynote session 2 – Friday, June 29, 9:30 – 11:00*

Teresa Caldeira is Professor of City and Regional Planning at the University of California, Berkeley. Her research focuses on predicaments of contemporary urban development and patterns of spatial segregation and social discrimination. She has been studying relationships between urban form and political transformation, particularly in the context of democratization and neoliberalization in cities of the global south. Her work is interdisciplinary, combining methodologies, theories, and approaches from the different social sciences, and especially concerned with reshaping ethnographic methods for the study of cities. *Keynote session 2 – Friday, June 29, 9:30 – 11:00*

Dominique Cardon is a sociologist working in France Télécom R&D's Usage Laboratory and associated researcher at the Centre for Research on Social Movements at the École des Hautes Études en Sciences Sociales (CEMS/EHESS). His research focuses on relations between use of new technologies and cultural and media activities. If new technology can contribute to the transformation of social relationships between individuals, it is also possible to modify the public arena, the media, and the way in which information is produced. The interconnection between sociability and the public arena is the starting point for various studies relating to cultural practices, alternative media, and "interactive" television programmes. He is particularly interested in the use of new technologies by international militants in the alter-globalization movement. *Keynote session 3 – Friday, June 29, 18:15 – 19:45*

Fadma Ait Mous obtained her Graduate Diploma in Political Science with a thesis on "The emergence process of the national movement in northern Morocco: 1915-1930: A study on social networks." She is currently preparing her PhD thesis on "Networks and the nationalist development process of the Moroccan national identity (1912-1944)" at the Faculty of Political Sciences, University Hassan II, Casablanca, under the supervision of Mr. Tozy.

Antonio Azuela de la Cueva is Professor at the MA in Social and Juridical Studies at the International Institute of Sociology of Law, Oñati, Basque. He has also been a senior researcher and visiting professor in many international universities. In addition to his long academic carrier, he has been Federal Attorney for environmental protection for the Mexican government and State Advisor on environmental and planning law (editor of over ten draft laws on state urban development). He has been Coordinator of the Laboratory on Documentation and Analysis of Corruption (Institute for Social Research, UNAM) and has published many books and articles on environmental issues and sociology of law of urban property.

Marie-Hélène Bacqué – After initial training as an architect and urban planner, and over ten years' work experience as Chief Engineer of the Public and Territorial Office and as Director of Studies at the Engineering and Urban Development Office, in 1994 Marie-Helene Bacque defended her thesis in Urban Studies at EHESS, supervised by Marcel Roncayolo. She has been assistant professor at the architecture school of Rennes (1994-97), lecturer at the French Institute of Urban and ENPC (1997-2004) and professor at the University of Evry (2005-2009). She has taught at the University of Paris West since 2009-10. She had several long stays as visiting scholar in foreign universities, such as Harvard University (Fulbright) and INRS-Urbanisation in Montreal. She currently heads the LAVUE Mosaics laboratory.

Ângela Ferreira is an internationally renowned Portuguese contemporary artist. Her art work reexamines the development of modernist narrative in the art and architecture field and creatively inquires about the space between its twofold agonistic utopias: the end of Art making through political revolution as an emancipatory imperative and the total autonomy of art form as a transhistorical imperative. Clearly positioned in what Hal Foster defines as a "Post-Modernism of resistance," an oppositional discourse on late capitalism, her art production also embodies Thomas Crow's assessment of contemporary advanced artistic culture as "a crossover between the seminar room and the art studio." She was the Portuguese representative for the 52nd Venice Biennale in 2007. She currently teaches in the sculpture department of Lisbon's Faculty of Fine Arts. *Keynote session 5 – Saturday, June 30, 14:30 – 16:10*

Boaventura de Sousa Santos is Professor of Sociology at the School of Economics, University of Coimbra (Portugal), Distinguished Legal Scholar at the University of Wisconsin-Madison Law School, USA, and Global Legal Scholar at the University of Warwick, UK. He is Director of the Center for Social Studies of the University of Coimbra, Scientific Coordinator of the Permanent Observatory for Portuguese Justice, and member of the Research Group on Democracy, Citizenship and Law (DECIDe) of the Centre. He has published widely on globalization, sociology of law and the state, epistemology, democracy, and human rights in Portuguese, Spanish, English, Italian, French and German.
