### Research Fellowship Grant

The Centre for Social Studies (CES), University of Coimbra, opens a call for applications for 1 research fellowship grant in the project **"Changing social attitudes towards gender diversity in children across Europe — DIVERSITY-CHILDHOOD"** (856680), funded by the Rights, Equality and Citizenship Programme (REC-AG) of the European Commission, coordinated at CES by Dr. Ana Cristina Santos, according to the following terms:

#### a. Project Description:

The EU Charter of Fundamental Rights underlines children's rights to protection, care and well-being. Despite significant work conducted in recent years, everyday children experience different kinds of violence. Gender and/or sexually non-conforming children are amongst the most vulnerable populations with respect to violence across Europe and beyond. DIVERSITY and CHILDHOOD (DaC) will conduct a participatory social diagnosis of the needs produced by current violence against LGBTQI+ and gender non-conforming children in eight European countries: Belgium, Greece, Hungary, Lithuania, Poland, Portugal, Slovenia and Spain. Activities developed by DIVERSITY and CHILDHOOD will target a variety of stakeholders and professionals who play different roles in supporting (or failing to support) LGBTQI+ and gender nonconforming children in 5 key areas of life: education, health, public space, media and the family. DaC activities include training for trainers, workshops, seminars, education modules for children and teachers, participation in the media, scientific articles and awareness materials, amongst others.

**Keywords:** gender-based violence; LGBTI and gender non-conforming children; childhood protection; equality; education and training.

**b. Scientific field:** Social Sciences and/or Humanities

#### c. Thematic description of the Fellow positions:

Applicants are expected to be doctoral candidates or early career researchers. Experience in the critical analysis of social, historical and political struggle for gender and sexual equality in Europe is valuable. Applicants should show a commitment or interest in struggles led by LGBTQI+ organizations in this field, and demonstrate specific knowledge of the Portuguese context.

#### d. Admission requirement:

Applicants must hold a master's degree in the Social Sciences or Humanities.

#### e. Selection criteria, and their evaluation weighting:

1. Master's degree in Sociology, Anthropology, Psychology, Gender or Feminist Studies, in a topic relevant for this project research (15%);
2. Professional and/or research experience in Gender Studies and/or LGBTQI+/Queer politics or other areas focusing on gender/LGBTQI+ issues (20%);

3. Documented training and experience in using qualitative methodologies in Social Sciences and conducting documental analysis (10%);
4. Experience in developing teaching/ training modules adjusted to different publics, including children (10%);
5. Proficiency in written and spoken English and Portuguese (20%);
6. Scientific publications or communications in topics relevant for this research project (15%);
7. Independent thinking, critical awareness and enthusiasm in integrating multidisciplinary and international teams (10%).

#### **d. Work plan:**

The selected researcher is expected to contribute to the implementation of the project's scientific tasks designed by the Principal Investigator, as well as to support any activities associated with the project's general goals. Especially, the selected researcher will be asked to gather, organize and analyse qualitative data in Portuguese and in English, develop tasks in preparation for and conducting fieldwork, guarantee administrative support in research management and networking with partners, and to support the team in: developing and conducting needs assessment and in mapping good practices (WP2), conducting interviews with stakeholders (WP2), designing working methods and implementing training activities (WP3 and WP4), planning and developing dissemination activities (WP5) including scientific and outreach events, drafts for outputs and dissemination material, among other tasks needed for a sound management and implementation of the project's goals.

#### **e. Applicable Legislation and Regulations:**

Act no. 40/2004, of August 18 (Research Fellow Statutes), and its follow-up changes, FCT (National Agency for Science and Technology) Regulations for Studentships and Fellowships (<https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt>), and Regulations for Fellowships at the Centre for Social Studies.

#### **f. Work place:**

The tasks will be performed at the Centre for Social Studies facilities in Coimbra or in other locations when necessary for the good implementation of the work plan, under the scientific supervision of the Principal Investigator, Ana Cristina Santos.

#### **g. Duration of the grant contract:**

The fellowship will last 6 months, starting in October, 2019. The grant contract may be extended for equal or different time periods, until the end of the project, depending on the good performance of the fellow and his/her developed activities as defined in the work plan, and on the Principal Investigator's assessment.

#### **h. Monthly allowance:**

The monthly stipend will be 1.200 Euro, to be paid by bank transfer on a monthly basis. The payment of the Voluntary Social Insurance and the Personal Accident Insurance adds up to this amount.

## **i. Selection process:**

Applicants will be selected based on their curricular evaluation. In case of equivalent curricular evaluations, the strongest applications will be evaluated through an interview, conducted in English, meant to assess the applicant's potential in integrating the project scientific dynamic and his/her motivation in pursuing studies related to the project's thematic areas. In case interviews are carried out, they will have a 25% weight in the final evaluation grade.

The jury has the right to decide not to select any of the applicants.

Applications must include:

- a) a one-page letter of intent/motivation in English;
- b) a detailed Curriculum Vitae (in English or in Portuguese);
- c) copies of degree certificates and of other relevant documents for eligibility purposes; and
- d) one to two (max.) written works, for example scientific publications, working papers, MA thesis chapter(s), or short paper(s) presented in a Conference.
